

AMENDMENT No. 1

This AGREEMENT entered into this _____ day of 2012, by and between the **Cuyahoga County**, Cuyahoga County, Ohio, and R.E.Warner & Associates, Inc. with offices located at LA Office Plaza 11, 25777 Detroit Road, Suite 200, Westlake, Ohio 44145.

WHEREAS, the County desires to have additional Architectural services; and

WHEREAS, R.E.Warner & Associates, Inc. is engaged in providing Architectural services,

NOW, THEREFORE, in consideration of the mutual agreements contained herein, the County and R.E.Warner & Associates, Inc. hereby agree as follows:

I. PURCHASE OF ADDITIONAL SERVICES

Subject to the terms and conditions in this contract, the County agrees to purchase certain services to be provided by R.E.Warner & Associates, Inc. for the purpose of Development of the Airport Administration Building Roof Replacement Project.

II. SCOPE OF ADDITIONAL SERVICES

R.E.Warner & Associates, Inc. agrees to provide the following additional services:

A. Complete new documentation " front end" documents for the construction project as adopted by Cuyahoga County.

B. Rebid Roof Replacement Project.

III. COMPENSATION

A. Additional compensation to R.E.Warner & Associates, Inc. shall be in an amount not to exceed \$ 3,650.00.

B. Budget for services provided in Attachment A

IV. TERM OF AGREEMENT

A. R.E.Warner & Associates, Inc. shall perform the services described effective October 15, 2010 thru March 30, 2013.

V. CONTRACT TERMINATION

The County may terminate this contract by delivery of a thirty (30) day advance written notice to R.E.Warner & Associates, Inc. Only those services actually provided through the effective date of termination will be paid.

VI. MODIFICATIONS

By the mutual consent of the County and R.E.Warner & Associates, Inc., this contract may be modified whenever such modifications are deemed necessary. Any such modifications to the contract shall be by written contract amendment signed by both parties.

VII. ANTI-DISCRIMINATION

The County and R.E.Warner & Associates, Inc. agree that in the performance of this contract, there shall be no discrimination against any person because of race, color, sex, religion, or national origin as provided in Title VII of the Civil Rights Act and any such violation, thereof, shall be deemed a breach of the contract.

R.E.Warner & Associates, Inc. shall not assign or transfer any interest in this contract without the express written consent of the County and may subcontract for services only as expressly provided in this contract.

X. INDEMNITY

A. R.E.Warner & Associates, Inc. agrees to release, indemnify and to hold harmless the County, R.E.Warner & Associates, Inc., and any and all officers, agents, servants or employees thereof, from any and all responsibility or liability for the negligent failure of R.E.Warner & Associates, Inc., to perform its duties and obligations under this contract.

XI. ENTIRE AGREEMENT



I ALSO AGREE ON BEHALF OF THE AFOREMENTIONED ENTITIES AND PERSONS, TO BE BOUND BY THE PROVISIONS OF CHAPTERS 304 AND 1306 OF THE OHIO REVISED CODE AS THEY PERTAIN TO ELECTRONIC TRANSACTIONS, AND TO COMPLY WITH THE ELECTRONIC SIGNATURE POLICY OF CUYAHOGA COUNTY.

Dear Ms. Shergalis:

Deborah Shaw requested a breakdown of the additional work required on the airport roof project during the time we were working with Mr. Carl Fixler. This extra work occurred due to the changes in the County organization after we submitted the final review package for Mr. Fixler's review.

1. Due to the organizational changes we were required to update the front end documents in the manual, forms, etc. There was also a long delay in the project awaiting direction. This task required an additional 16 hours to update the manual as well as two additional review meetings to revise updates and final documents which required an additional eight hours and added printing costs.

The design documents (drawings, specs and bid packages) and invitation to bid documents were also revised which required eight hours and added printing costs.

2. The prebid meeting and follow up was conducted but will need to occur again because the first bids were dismissed by the County. We will require additional time to reissue and print documents and attend the prebid meeting at the airport. The additional time is 12 hours for this task.
3. An additional four hours of project management and meetings were required for the revisions to the new bid package, etc.

The additional cost for this work is \$3,650. We will complete the following work associated with the construction administration services which yet to be completed under the original contract:

- Two meetings at the airport
- Final document review meeting at the County office
- Construction administration
- Observation at the airport


