

CONTRACT AMENDMENT

by and between

CUYAHOGA COUNTY, OHIO

and

ADVANTRA GROUP INC.

THIS CONTRACT AMENDMENT, made and entered into this 22 day of AUGUST, 2012, by and between Cuyahoga County, Ohio ("the County"), on behalf of the Cuyahoga County Medical Examiner's Office and Advantra Group Inc., an Ohio corporation with offices located at 4553 Johnston Parkway; Cleveland, Ohio 44128 (hereinafter the "Provider"), incorporates the following into County Resolution 103748, CE1000750-01,02,03,04 on Requisition number RQ CR-10-17777 to provide an additional \$791.00 to the Medical Examiner's Office; an additional \$2,868.00 to the Common Pleas/Adult Probation; an additional \$565.00 to Juvenile Court; the Sheriff's Department has no need for additional funds, for a total increase of \$4,224.00 for services rendered for the period of September 1st, 2012 – December 31st, 2012.

ADHERENCE TO ELECTRONIC SIGNATURE POLICY OF COUNTY:

By entering into this Contract Amendment, I agree on behalf of the contracting or submitting business entity, its officers, employees, subcontractors, sub grantees, agents or assigns, to conduct this transaction by electronic means by agreeing that all documents requiring County signatures may be executed by electronic means, and that the electronic signatures affixed by Cuyahoga County to said documents shall have the same legal effect as if that signature was manually affixed to a paper version of the document. I also agree on behalf of the aforementioned entities and persons, to be bound by the provisions of Chapter 304 and 1306 of the Ohio Revised Code as they pertain to electronic transactions, and to comply with the electronic signature policy of Cuyahoga County.

ADDITIONAL FUNDS:

The total funds for the aforementioned agencies are to be increased as follows: Medical Examiner is to be increased from \$54,000.00 to \$54,791.00; Common Pleas/Adult Probation is to be increased from \$27,000 to \$29,868.00; Juvenile Court is to be increased from \$6,000 to \$6565.00; Sheriff Department will not increase.

ADDITIONAL TERM OF CONTRACT:

The original length of the contract was September 1st, 2010 - August 31st, 2012 and will be amended to continue from September 1st, 2012 – December 31st, 2012.


All remaining terms and conditions of the original contract shall remain in effect.


