

Amendment to Contract

THIS AGREEMENT (the "Amendment") is made and entered into this _____ day of _____, 2012 by and between Cuyahoga County, Ohio ("the County"), on behalf of the Information Services Center and **Sprint Solutions, Inc.**, a Delaware corporation with principal offices at 12502 Sunrise Valley Drive MS: VARESA0208, Reston, VA 20196. ("Sprint").

WHEREAS, the County and Sprint entered into Contract No. CE1000769-01 for wireless voice and data communication services for a period of forty months from the commencement date September 1, 2010 through December 31, 2013 via State of Ohio TSR Master Service Agreement; and

WHEREAS, the County desires to amend CE 1000769 to exercise their option to Sprints offer of a no cost allotment, the value up to \$77,227.00, (This reduces the buildout allotment to zero dollars), for in-building coverage enhancements. This no cost to the County option, will authorize Sprint to enhance Sprint Signal coverage at the Cuyahoga County Juvenile Justice Center by installing Customer Network Solutions (CNS) effective 6/1/12; and

WHEREAS, the County and Sprint have mutually agreed that changes are necessary to the terms and provisions contained in the Contract; and

WHEREAS, this Amendment will not increase the not to exceed price of the Contract to One Million Seven Hundred Eighty Thousand Fifty Eight Dollars and Seventy Three Cents (\$1,780,058.73); and

NOW, THEREFORE, in consideration of the mutual promises contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Sprint and the County agree as follows that the original contract shall be amended as follows:

1. ARTICLE II – SCOPE OF WORK

Section 2.1 Rendering of Services. Shall be amended shall authorize Sprint to enhance Sprint signal coverage by installing Customer Network Solutions (CNS) equipment and networks within Juvenile Justice Center. The details of the agreement and scope of work are attached as Exhibit 1 to this Amendment, effective June 1st, 2012, at no additional cost to the County. The not to exceed cost of the Contract will continue to be One Million Seven Hundred Eighty Thousand Fifty Eight Dollars and Seventy Three Cents (\$1,780,058.73).


All other terms and conditions of the original contract, and the prior Amendments thereto, which are not expressly modified herein, shall remain in full force and effect.
