## AMENDMENT NO. 1

THIS CONTRACT AMENDMENT made and entered into this \_\_\_\_\_ day of \_\_\_\_\_\_, 2011 by and between the County of Cuyahoga, Ohio (the "County"), on behalf of Employment & Family Services (the "Agency") and <u>Lutheran Metropolitan Ministry.</u>, a nonprofit organization, with principal offices located at 1468 West 25<sup>th</sup> Street, Cleveland, Ohio 44113, (the "Provider").

## WITNESSETH:

WHEREAS, in order to continue to provide a Job Readiness, Job Search, Job Placement and Job Retention Program for OWF and/or FAET eligible recipients, amendments to Contract Encumbrance No. CE-1000778-01 are necessary:

**THEREFORE**, the following amendments to the aforementioned Contract are agreed to by and between the parties hereto, as follows:

- 1. That the reason for this amendment is to extend the period of performance and to increase the contract amount to provide for the continuation of services.
- 2. That Paragraph I (Term) the end date of the contract amended by extending the end date from <u>September 30, 2011</u> to <u>September 30, 2012</u>.
- 3. That the amount of the contract is increased by \$447,338.15 from \$496,930.00 to \$944,268.15
- 4. That the number of Job Readiness/Job Search Training Sessions is increased by <u>20</u> from <u>20</u> to <u>40</u> times <u>\$7,460.00</u> or <u>\$298,400.00</u>.
- 5. That the number of Job Placement and Job Retention Case Management payments is increased by 12 from 12 to 24; 2 @ \$14,483.77 and 22@ \$14,483.75 or \$347,610.04.
- 6. That the number of Job Placements is increased by <u>175</u> from <u>245</u> to <u>420</u> times <u>\$141.98</u> or <u>\$59,631.60</u>.

- 7. That the number of 90 Day Job Retentions is increased by <u>105</u> from <u>147</u> to <u>252</u> times \$354.95 or \$89,447.40.
- 8. That the number of 180 Day Job Retentions is increased by <u>88</u> from <u>123</u> to <u>211</u> times <u>\$707.01</u> or <u>\$149,179.11</u>.
- 9. That the effective date of this amendment is October 1, 2011.

All other "Terms and Conditions" and EXHIBITS of the aforementioned Contract Agreement remain as originally written.
