



AMENDMENT TO CONTRACT

THIS AMENDATORY CONTRACT made and entered into this _____ day of _____, 2011 by and between the Cuyahoga County, Ohio (the "County"), on behalf of the Department of Development and WECO Fund Inc., a corporation not-for-profit, with principal offices located at 3209 Chester Avenue, Cleveland, Ohio 44114, (the "Subrecipient").

WITNESSETH:

WHEREAS, the County and WECO Fund Inc entered into a Contract #CE1000822-01 dated December 1, 2010 (hereinafter called the "Contract") whereby the WECO Fund Inc., a corporation not-for-profit, was awarded \$250,000.00 in funds for an activity entitled Microenterprise loans benefiting low- and moderate-income persons; and

WHEREAS, the Contract expires on November 30, 2011 and

WHEREAS, the amount of the Contract reads \$250,000.00, and

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained, the County and WECO Fund Inc., a corporation not-for-profit, hereby agree as follows:

1. Except as herein specifically amended, all terms used herein shall have the same meanings as in the Contract.
2. The date of November 30, 2011 appearing in Item II of the Contract shall be and is hereby changed to April 30, 2012.
3. Except as herein specifically amended, all of the terms and provisions contained in the Contract are hereby ratified and confirmed and said Contract is hereby incorporated to the same extent as if fully rewritten herein.

This Contract may be executed in five copies, each of which shall constitute an original, but when taken together shall constitute but one Contract.

IN WITNESS WHEREOF, the County and WECO Fund Inc., a corporation not-for-profit, have caused this Amendment to Contract to be executed the day, month and year first above written.

By entering into this (agreement/contract/amendment to agreement or contract) or (by submitting a bid) or (by submitting a proposal) I agree on behalf of the contracting or submitting business entity, its officers, employees, subcontractors, sub-grantees, agents or assigns, to conduct this transaction by electronic means by agreeing that all documents requiring county signatures may be executed by electronic means, and that the electronic signatures affixed by the county to said documents shall have the same legal effect as if that signature was manually affixed to a paper version of the document. I also agree on behalf of the aforementioned entities and persons, to be bound by the provisions of chapters 304 and 1306 of the Ohio revised code as they pertain to electronic transactions, and to comply with the electronic signature policy of Cuyahoga County
