AMENDMENT NO.1 CE1000872-01

THIS Amendment is to Contract CE1000872-01. Contract CE1000872-01 was approved by the County of Cuyahoga, Ohio (the "County") on November 9, 2011. Contract CE1000872-01 is between the County, on behalf of its Division of Children and Family Services and West Side Ecumenical Ministry, a private, not for profit entity, identified as the Provider.

Amendment, part 1:

WHEREAS <u>West Side Ecumenical Ministry</u> and the Cuyahoga County, Ohio now desire to further amend the contract to substitute <u>Center for Families and Children</u> for <u>West Side</u> <u>Ecumenical Ministry</u> under the contract. The parties agree that for all purposes the rights and interests of <u>West Side Ecumenical Ministry</u> identified in the original contract (and subsequent amendments) are transferred to <u>Center for Families and Children</u> effective with signature of this amendment.

Reason for Amendment: West Side Ecumenical Ministry has changed their name to Center for Families and Children, effective April 18, 2012. Therefore, the name of the provider must be modified to reflect this change.

The following represents the terms of the Amendment:

- A. Changes the name of the Provider from <u>West Side Ecumenical Ministry</u> to <u>Center for Families and Children</u>, effective March 19, 2012.
- B. A W-9 for Center for Families and Children is attached.

Amendment, part 2:

The original contract, any other Amendments which may exist, and this Amendment are subject to all other terms, conditions and obligations set forth in the original agreement that have not been modified by the terms of this Amendment or modified based upon the purpose for this Amendment.

Amendment, part 3: Electronic Signature

BY ENTERING INTO THIS AMENDMENT, PROVIDER AGREES ON BEHALF OF THE CONTRACTING OR SUBMITTING BUSINESS ENTITY, ITS OFFICERS, EMPLOYEES, SUBCONTRACTORS, SUBGRANTEES, AGENTS OR ASSIGNS, TO CONDUCT THIS

TRANSACTION BY ELECTRONIC MEANS BY AGREEING THAT ALL DOCUMENTS REQUIRING COUNTY SIGNATURES MAY BE EXECUTED BY ELECTRONIC MEANS, AND THAT THE ELECTRONIC SIGNATURES AFFIXED BY THE COUNTY TO SAID DOCUMENTS SHALL HAVE THE SAME LEGAL EFFECT AS IF THAT SIGNATURE WAS MANUALLY AFFIXED TO A PAPER VERSION OF THE DOCUMENT. I ALSO AGREE ON BEHALF OF THE AFOREMENTIONED ENTITIES AND PERSONS, TO BE BOUND BY THE PROVISIONS OF CHAPTERS 304 AND 1306 OF THE OHIO REVISED CODE AS THEY PERTAIN TO ELECTRONIC TRANSACTIONS, AND TO COMPLY WITH THE ELECTRONIC SIGNATURE POLICY OF CUYAHOGA COUNTY.
