**AMENDMENT NO.1
CE1000880-01**

THIS Amendment is to Contract CE1000880-01. This document amends the Evidence-Base Family Focused Parenting Services Contract CE1000880-01 which is effective for the time period beginning December 1, 2011 between two agencies of County of Cuyahoga, Ohio (the "County"). Contract CE1000880-01 is between the County, on behalf of its Division of Children and Family Services and **The Cleveland Christian, Incorporated. Trauma Focused Cognitive Behavioral Therapy (TF-CBT)** a private, not for profit entity, identified as the Provider to amend the end date.

Amendment, part 1:

Paragraph 2. Amendment No.1 CE1000880-01 will read, Amendment No.1 CE1000880-01 of the contract will be to extend the end date of the contract from December 1, 2011 to November 30, 2012.

2. CONTRACT PERIOD

A. *Contract Period*

This Contract will be effective for the twenty four (24) month period from December 1, 2010 through November 30, 2012, both inclusive, unless otherwise terminated, at an amount not to exceed the following amount which shall be identified as the "Maximum Dollar Amount", based on the current per diem for each service provided.

The Maximum Dollar Amount is \$43,809.00.

Amendment, part 2:

The original contract, any other Amendments which may exist, and this Amendment are subject to all other terms, conditions and obligations set forth in the original agreement that have not been modified by the terms of this Amendment or modified based upon the purpose for this Amendment.

Amendment, part 3: Electronic Signature

BY ENTERING INTO THIS AMENDMENT, PROVIDER AGREES ON BEHALF OF THE CONTRACTING OR SUBMITTING BUSINESS ENTITY, ITS OFFICERS, EMPLOYEES, SUBCONTRACTORS, SUBGRANTEES, AGENTS OR ASSIGNS, TO CONDUCT THIS TRANSACTION BY ELECTRONIC MEANS BY AGREEING THAT ALL DOCUMENTS REQUIRING COUNTY SIGNATURES MAY BE EXECUTED BY ELECTRONIC MEANS, AND THAT THE ELECTRONIC SIGNATURES AFFIXED BY THE COUNTY TO SAID DOCUMENTS SHALL HAVE THE SAME LEGAL EFFECT AS IF THAT SIGNATURE WAS MANUALLY AFFIXED TO A PAPER VERSION OF THE DOCUMENT. I ALSO AGREE ON BEHALF OF THE AFOREMENTIONED ENTITIES AND PERSONS, TO

BE BOUND BY THE PROVISIONS OF CHAPTERS 304 AND 1306 OF THE OHIO REVISED CODE AS THEY PERTAIN TO ELECTRONIC TRANSACTIONS, AND TO COMPLY WITH THE ELECTRONIC SIGNATURE POLICY OF CUYAHOGA COUNTY.
