The before identified Contract was previously approved by the County of Cuyahoga, Ohio (the "County") and is between the County, on behalf of its Division of Children and Family Services and **Cleveland Christian Home, Incorporated**, identified for the purpose of this amendment as the Provider.

WHEREAS, the purpose of the Amendment is to replace paragraph 2.A. of the Contract with an amended paragraph 2.A.

THEREFORE, the Contract will be amended as reflected below.

Amendment, part 1:

The above identified Contract will be amended to: (1) extend the Contract time period to **November 30, 2013**, and (2) to decrease the maximum dollar amount by **(\$84,166.00)**. To accomplish these purposes, the parties hereby amend the original contract. After this Amendment is approved, paragraph 2.A. will read, as follows:

2. TERMS & CONTRACT PERIOD

A. Contract Period

This Contract will be effective for thirty-six (36) month period from **December 1, 2010** through **November 30, 2013**, both inclusive, unless otherwise terminated, at an amount not to exceed the following amount which shall be identified as the "Maximum Dollar Amount". The Amendment will decrease **(\$84,166.00)** of the Contract amount. Therefore, the **Maximum Dollar Amount is \$28,056.00.**

Amendment, part 2:

The original Contract, any other Amendments which may exist, and this Amendment are subject to all other terms, conditions and obligations set forth in the original Contract that have not been modified by the terms of this Amendment or modified based upon the purpose for this Amendment.


Amendment, part 3:

Electronic Signature

BY ENTERING INTO THIS AMENDMENT, PROVIDER AGREES ON BEHALF OF THE CONTRACTING OR SUBMITTING BUSINESS ENTITY, ITS OFFICERS, EMPLOYEES, SUBCONTRACTORS, SUBGRANTEES, AGENTS OR ASSIGNS, TO CONDUCT THIS TRANSACTION BY ELECTRONIC MEANS BY AGREEING THAT ALL DOCUMENTS REQUIRING COUNTY SIGNATURES MAY BE EXECUTED BY ELECTRONIC MEANS, AND THAT THE ELECTRONIC SIGNATURES AFFIXED BY THE COUNTY TO SAID DOCUMENTS SHALL HAVE THE SAME LEGAL EFFECT AS IF THAT SIGNATURE WAS MANUALLY AFFIXED TO A PAPER VERSION OF THE DOCUMENT. PROVIDER ALSO AGREES ON BEHALF OF THE AFOREMENTIONED ENTITIES AND PERSONS, TO BE BOUND BY THE PROVISIONS OF CHAPTERS 304 AND 1306 OF THE OHIO REVISED CODE AS THEY PERTAIN TO ELECTRONIC TRANSACTIONS, AND TO COMPLY WITH THE ELECTRONIC SIGNATURE POLICY OF CUYAHOGA COUNTY.


Wherefore, the parties have entered into Amendment and this Amendment has been approved the County.


