AMENDMENT NO.1 CE1000883-01

THIS Amendment is to Contract CE1000883-01. This document amends the Intensive Case Management Contract CE1000883-01 which is effective for the time period beginning December 1, 2010 between two agencies of County of Cuyahoga, Ohio (the "County"). Amendment, part 1:
