

This Contract made and entered into this 1<sup>st</sup> day of January, 2011 by and between the County of Cuyahoga, Ohio ("the County"), and Community Re-Entry, Inc., a non-profit organization Corporation, with principal offices located at 1468 West 25<sup>th</sup> Street, Cleveland, Ohio 44113( the "Provider"), hereinafter referred to as "CR".

Whereas the Sheriff of Cuyahoga County, Bob Reid, has the responsibility to operate the jail of said County and to provide appropriate social services and has the responsibility to administer said services in a cost efficient manner.

NOW THEREFORE, it is hereby acknowledged and agreed as follows:

**ARTICLE 1 -- Scope of Work:** CR shall provide the services of an individual qualified to function as the WRRN County Jail Liaison Social Worker to provide community linkage services for female inmates incarcerated at the County Jail. This individual shall be responsible for the following:

- A. Coordination of all WRRN services in the jail setting.
- B. One-on-one case management for WRRN participants.
- C. Organization of and response to all "kites" sent to WRRN by inmates.
- D. Therapeutic support group Facilitation.
- E. Group curriculum development.
- F. Development and facilitation of WRRN orientation groups.
- G. Community linkage and referrals.
- H. Establishing effective working relationship with other jail-based social and mental health services.
- I. Assists in coordination of field placement responsibilities for MSASS intern.
- J. Reporting to Supervisor of Social Services for on-site supervision.

**ARTICLE 2 --Fees:** The contracting agency agrees to pay CR \$25,000 per annum for a minimum of 16 hours per week of services to be provided in the Jail by WRRN County Liaison Social Worker.

**ARTICLE 3 --Deliverables:** The WRRN County Liaison Social Worker will provide statistical reports to document persons receiving services and an annual report to demonstrate impact of services rendered.

**ARTICLE 4 -- Length of Contract and Payment:** This contract will commence on January 1, 2011 and end on December 31, 2011. Payment will be made in four (4) installments every three (3) months in the amount of \$6,250 per installment.

**ARTICLE 5 --Indemnification:** CR shall indemnify and save harmless the County of Cuyahoga, the Sheriff's Office, and all of their officers, agents, and employees from and against all claims, damages, losses and expenses of any kind whatsoever asserted against them caused in whole or part by the acts or omissions of CR, its employees or agents in the provision of services pursuant to this Agreement.

**ARTICLE 6 --Independent Contractor:** No relationship of employer or employee is created by this Agreement. It being understood that CR will hereunder act as an independent contractor. CR, its agents and employees shall not have any claim against the County of Cuyahoga, or Sheriff's Office, under this Agreement for vacation pay, sick leave, retirement benefits, P.E. R.S., workers compensation, disability, unemployment, insurance benefits or employee benefits of any kind.

**ARTICLE 7 -- Insurance:** CR carries liability insurance and shall hold harmless the County of Cuyahoga and the Sheriff's Department, and all of their officers, agents and employees from claims, damages, losses and expenses of any kind whatsoever asserted against them caused in whole or part by the acts or omissions of CR, its employees or agents in the provision of services pursuant to this Agreement.

**ARTICLE 8 -- Out Clause:** If either party wishes to discontinue this agreement, thirty (30) days written notice must be provided to the other parties.

**ARTICLE 9 -- Entire Agreement:** This Agreement is the entire Agreement between the parties with respect to services provided hereunder and supersedes all prior Agreements, proposals, understandings, whether written or oral. This Agreement may not be amended except by a subsequent written agreement signed by both parties.


