

THIS AGREEMENT made and entered into this _____ day of _____, 20____ by and between the County of Cuyahoga, Ohio

and the Great Lakes Construction Co., an Ohio Company with principal office located at 2881 Great Lakes Way, Macedonia, Ohio 44233.

WITNESSETH that whereas in the performance of Contract No. CE#100235-01 between the above named

parties, calling for the Construction of a grade separation on Rich Road over the Norfolk Southern Railroad in the City of Olmsted Falls and Olmsted Twp.

it is the opinion of the County of Cuyahoga, Ohio that it is necessary to make alterations and modifications as follows in said contract in order that the work be properly completed:

The New item of work was added as a result of a value engineering analysis performed by the contractor's Professional Engineer which was reviewed by the County's Geotechnical Consultant and they were in agreement that in making this change, a time savings resulted and a cost savings of approximately \$28,000.

WHEREAS, the Contractor has agreed and by these presents does agree to perform the work necessary to complete the contract in accordance with the alterations and modifications desired by the County at the following prices for the following work viz:

Therefore, can be decreased by (\$18,750) continue construction as per plan.

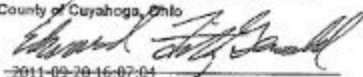

By entering into this amendment I agree on behalf of the contracting business entity, it's officers, employees, subcontractors, subgrantees, agents or assigns, to conduct this transaction by electronic means by agreeing that all documents requiring County signatures may be executed by electronic means and that the electronic signatures affixed by the County to said documents shall have the same legal effect as if that signature was manually affixed to a paper version of the document. I also agree on behalf of the aforementioned entities and persons, to be bound by the provisions of Chapter 304 and 1306 of the Ohio Revised Code as they pertain to electronic transactions, and to comply with the electronic signature policy of Cuyahoga County.

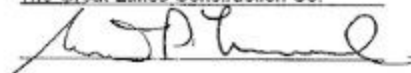
Nothing in this agreement shall in any way release either party from any of the obligations of the original contract.

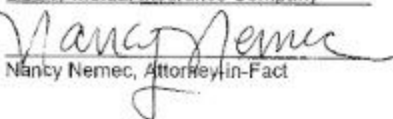
