Amendment to contract CE#1100290-01 entered into this _____ day of _____, 2012, by and between Cuyahoga County, Ohio (the "County"), on behalf of the Office of Early Childhood ("OEC") and the Educational Service Center of Cuyahoga County ("ESC"), a political subdivision of the State of Ohio, with principal office located at 5811 Canal Road, Valley View, Ohio 44125 on behalf of Help Me Grow of Cuyahoga County for the purpose of amending the contract to add additional funds as follows:

1. **Amending Article III, "CONTRACT VALUE" to read:**
This amendment shall total **\$185,201.00** from an aggregated contract award amount of **\$531,112.00** to **\$716,313.00**. Total expenditures shall be limited to the aggregated amounts by account/program area as outlined in the **Revised Exhibit A** (attached):
2. **All other terms of the contract are hereby reaffirmed.**
3. **IN WITNESS WHEREOF**, the County and the ESC have entered into this contract amendment as of the day and year first written above.

BY ENTERING INTO THIS CONTRACT AMENDMENT, I AGREE ON BEHALF OF THE CONTRACTING OR SUBMITTING BUSINESS ENTITY, ITS OFFICERS, EMPLOYEES, SUBCONTRACTORS, SUBGRANTEES, AGENTS OR ASSIGNS, TO CONDUCT THIS TRANSACTION BY ELECTRONIC MEANS BY AGREEING THAT ALL DOCUMENTS REQUIRING COUNTY SIGNATURES MAY BE EXECUTED BY ELECTRONIC MEANS, AND THAT THE ELECTRONIC SIGNATURES AFFIXED BY THE COUNTY TO SAID DOCUMENTS SHALL HAVE THE SAME LEGAL EFFECT AS IF THAT SIGNATURE WAS MANUALLY AFFIXED TO A PAPER VERSION OF THE DOCUMENT.

I ALSO AGREE ON BEHALF OF THE AFOREMENTIONED ENTITIES AND PERSONS, TO BE BOUND BY THE PROVISIONS OF CHAPTERS 304 AND 1306 OF THE OHIO REVISED CODE AS THEY PERTAIN TO ELECTRONIC TRANSACTIONS, AND TO COMPLY WITH THE ELECTRONIC SIGNATURE POLICY OF CUYAHOGA COUNTY.


