AMENDMENT TO THE  
APPLEWOOD CENTERS, INC.  
SEX OFFENDER ASSESSMENT AND TREATMENT CONTRACT

THIS AMENDMENT is entered into this \_\_\_\_ day of \_\_\_\_\_, 2011 by and between the County of Cuyahoga, Ohio (hereinafter called the "COUNTY"), the Cuyahoga County Juvenile Court (hereinafter called the "COURT") and **Applewood Centers, Inc.**, a corporation not-for-profit, with principal offices located at 2525 East 22<sup>nd</sup> Street, Cleveland, OH 44115, [REDACTED] (hereinafter called the "VENDOR").

WITNESS THAT:

WHEREAS, the COURT desires to engage the VENDOR'S professional and technical services to conduct an **Adolescent Sex Offender assessment and MST-PSB treatment** program.

NOW, THEREFORE, it is agreed that the CONTRACT by and between the COUNTY, the COURT and the VENDOR for services to be rendered from February 1, 2011 to January 31, 2012 is hereby amended to include the following revision to sections:

- To increase the funds in the amount of \$50,000.00. This changes the not-to-exceed value of the contract from \$50,000.00 to \$100,000.00.
- To extend the agreement for twelve (12) additional months, from February 1, 2012 to January 31, 2013.
- To change the UNIT RATE of \$106.85/per hour for each non-Medicaid eligible YOUTH shall be paid by the COURT to the VENDOR for each YOUTH receiving MST-PSB treatment counseling services to \$90.00/per diem rate.
- ELECTRONIC SIGNATURES - By entering into this CONTRACT, the VENDOR agrees on behalf of the contracting business entity, its officers, employees, subcontractors, subgrantees, agents or assigns, to conduct this transaction by electronic means by agreeing that all documents requiring county signatures may be executed by electronic means and that the electronic signatures affixed by the COUNTY to said documents shall have the same legal effect as if the signature was manually affixed to a paper version of the document. The VENDOR also agrees on behalf of the aforementioned entities and persons to be bound by the provisions of chapters 304 and 1306 of the Ohio Revised Code as they pertain to electronic transactions, and to comply with the electronic signature policy of Cuyahoga County.

All other sections of the original contract shall remain the same.

IN WITNESS WHEREOF, the COUNTY, the COURT and the VENDOR have executed this AMENDMENT as of the date first above written.
