This Amendatory Contract made as of \_\_\_\_\_ day of \_\_\_\_\_, A.D., 2012 by and between the County of Cuyahoga, Ohio (the "**County**"), on behalf of the Cuyahoga County Common Pleas Court and the Cuyahoga County Corrections Planning Board (hereinafter "**Court**") and Cuyahoga County Community Corrections Association (4CA), Inc., a corporation not-for-profit, with principal offices located at 1710 Prospect Avenue, Cleveland, Ohio 44115 (hereinafter "**4CA**"), acting as the fiscal agent for the participating halfway house agencies (hereinafter "**Provider Panel**"), named in Attachment "A" of this Amendatory Contract.

**Witnesseth:**

**Whereas**, the County, 4CA and the Provider Panel entered into a Contract (Board of Control Approval BC2011-23) dated June 27, 2011 (hereinafter called "Contract") whereby 4CA was awarded \$425,000.00 in funds for an activity entitled Halfway House Substance Abuse Treatment Program, and

**Whereas**, the amount of the Contract reads:

**\$425,000.00 for the period July 1, 2011 through June 30, 2012**, and

**Now, therefore**, in consideration of the mutual covenants and contracts herein contained, the County, 4CA and the Provider Panel hereby agree as follows:

1. Except as herein specifically amended, all terms used herein have the same meanings in the Contract.
2. The amount of the contract is increased by \$47,845.00 to \$472,845.00. The amount of the Contract shall read **\$472,845.00 for the period July 1, 2011 through June 30, 2012**. This amendment is necessary so that the Provider Panel may provide residential treatment services to additional offenders placed into treatment programs by order of the Court. This additional funding is provided by the Ohio Department of Rehabilitation and Correction's Community Correction Act 407 ISP Grant (\$21,845.00) FY2012 and 408 JCM Grant (\$26,000.00) FY2012. The additional funding is for treatment of moderate to high risk offenders.
3. Except as herein specifically amended, all of the terms and provisions contained in the Contract and the first Contract amendment are hereby ratified and confirmed and said Contract is hereby incorporated to the same extent as if fully rewritten herein.
