

CONTRACT AMENDMENT

THIS CONTRACT AMENDMENT, made and entered into this 1<sup>st</sup> day of November, 20 12, by and between the Cuyahoga County, Ohio, (the "County") on behalf of the Department of Public Works and Mid-West Presort Mailing Services, Inc., an Ohio Corporation with offices located at 2222 West 110<sup>th</sup> Street, Cleveland, Ohio 44102 (the "Vendor"), incorporates the following into County Contract CE-1100371-01 on Requisition No. 18620, FURNISHING PRESORT MAILING SERVICES TO VARIOUS COUNTY AGENCIES for the DEPARTMENT OF PUBLIC WORKS, of Cuyahoga County, Ohio for the period: February 1, 2011 thru January 31, 2013, extending the Contract term one (1) year to January 31, 2014 in accordance with the specifications and to the satisfaction and acceptance of the County, with the aforesaid sum NOT-TO-EXCEED twenty nine thousand one hundred sixty dollars (\$29,160.00).
