#### Amendment, part 1:

The above identified Contract will be amended to: (1) extend the Contract time period to **December 31, 2012**. To accomplish these purposes, the parties hereby amend the original contract. After this Amendment is approved, Section 2, paragraph one will read, as follows:

# 2. SCOPE OF SERVICES

Under the terms of this contract, The UNIVERSITY shall provide all services as set forth below within this contract, during the period **July 1**, **2011 through December 31**, **2012** or as adjusted by written agreement signed by both parties, and approved. There are three primary scopes of services for this contract: 1) Cuyahoga Tapestry System of Care (CTSOC) Evaluation; 2) Youth and Family Community Partnership (YFCP) Evaluation; and 3) Wraparound Fidelity Data Collection and Evaluation.

The Maximum Dollar Amount is \$425,000.00.

### Amendment, part 2:

The original Contract, any other Amendments which may exist, and this Amendment are subject to all other terms, conditions and obligations set forth in the original Contract that have not been modified by the terms of this Amendment or modified based upon the purpose for this Amendment.
