



AMENDMENT TO CONTRACT
CE1200040-01

Entering into a Contract Amendment by and between the County of Cuyahoga, Ohio (the "County") and Case Western Reserve University (CASE) a private University with principal offices located at 10900 Euclid Avenue, Nord 6th floor, Cleveland, Oh 44106 (CASE) in connection with CE1200040-01. This amendment is to increase the dollars in connection with the Department of Health and Human Services, Substance Abuse and Mental Health Services Administration (SAMHSA), Adult Treatment Drug Courts Grant Award for the second year of funding under the Grant.

The approved increase amount specified by the grant and in the original executed contract shall not exceed Sixty Five Thousand Dollars and Zero Cents (**\$65,000.00**) for approved and identified Grant activities as specified in Attachment "A" incorporated herein as part of this Amendment.

CUYAHOGA COUNTY HELD HARMLESS

The PROVIDER agrees to indemnify and hold harmless (and at the COUNTY'S request, defend) Cuyahoga County and its employees and elected officials, (each of which persons and organizations is hereinafter called an "indemnatee") from and against any and all claims, loss, damages, liability, costs, expense, judgment or obligation whatsoever, for or in connection with injury (including death) or damage to any person or property to the extent resulting from, the PROVIDER's negligent performance or PROVIDER's negligent failure to perform obligations hereunder applies without limitation to injury or damage to third parties and Cuyahoga County and its respective property.


The COUNTY will defend, indemnify and hold the PROVIDER harmless from any claim, suit, loss, cost, damage, liability or expense arising out of COUNTY's performance or actions under this Agreement, the COUNTY's use of any information, results, or Deliverables, PROVIDER's use of COUNTY Resources for the purposes provided by COUNTY, and/or claims by or relating to COUNTY Staff. Such defense will be conducted by attorneys reasonably acceptable to both parties. This obligation shall survive termination of the Agreement.


CUYAHOGA COUNTY ORDINANCES


