

AMENDMENT

This Amendatory Contract made this 19 day of September, 2012 is to amend Contract No. CE1200094-01 entered into by and between Cuyahoga County, Ohio on behalf of the Cuyahoga County Office of Reentry (the "County") and Case Western Reserve University Begun Center for Violence Prevention Research & Education, a non-profit corporation, with principal offices located at Mandel School of Applied Social Science, 10900 Euclid Avenue, Cleveland, Ohio 44106-7164c (the "Provider").

WHEREAS, the parties have mutually agreed that changes are necessary to the contract as follows:


1. The reason for this amendment is to extend the time period on this contract amendment only.
2. The Contract period shall be extended from October 1, 2012 to March 31, 2013.
3. During the term of this Contract Amendment, Case Western Reserve University Begun Center for Violence Prevention Research & Education shall continue to provide the services outlined in the original contract and any subsequent amendments approved by the County and will provide services as outlined in Appendices "A" and "B" attached hereto.

All other terms and conditions of the original contract, which are not expressly modified herein, shall remain in full force and effect.

BY ENTERING INTO THIS AMENDMENT TO CONTRACT I AGREE ON BEHALF OF THE CONTRACTING OR SUBMITTING BUSINESS ENTITY, ITS OFFICERS, EMPLOYEES, SUBCONTRACTORS, SUBGRANTEES, AGENTS OR ASSIGNS, TO CONDUCT THIS TRANSACTION BY ELECTRONIC MEANS BY AGREEING THAT ALL DOCUMENTS REQUIRING COUNTY SIGNATURES MAY BE EXECUTED BY ELECTRONIC MEANS, AND THAT THE ELECTRONIC SIGNATURES AFFIXED BY THE COUNTY TO SAID DOCUMENTS SHALL HAVE THE SAME LEGAL EFFECT AS IF THAT SIGNATURE WAS MANUALLY AFFIXED TO A PAPER VERSION OF THE DOCUMENT. I ALSO AGREE ON BEHALF OF THE AFOREMENTIONED ENTITIES AND PERSONS, TO BE BOUND BY THE PROVISIONS OF CHAPTERS 304 AND 1306 OF THE OHIO REVISED CODE AS THEY PERTAIN TO ELECTRONIC TRANSACTIONS, AND TO COMPLY WITH THE ELECTRONIC SIGNATURE POLICY OF CUYAHOGA COUNTY.


