

**COUNTY OF CUYAHOGA
CONTRACT**

THIS Contract made and entered into this 16 day of 2012, 2012 by and between the County of Cuyahoga, Ohio (the "County"), and Ohio Graphics, Inc. (the "Contractor"), with principal offices located at 6563 Cochran Road Solon, Ohio 44139.

WITNESSETH:

That for and in consideration of payments hereinafter mentioned, to be made by the County, the Contractor agrees to perform all services necessary to obtain prompt and thorough service by providing emergency and/or general services for the Two-Color Sakurai/Oliver 266-EP2 Offset Press and the Hamada 661-XL for the period May 1, 2012 thru April 30, 2014, in accordance with the specifications on EQ23403 and to the satisfaction and acceptance of the County.

The Contractor further covenants and agrees that the following documents shall be bound with or accompany and be an essential part of this contract: specifications predicated to this contract; the general clauses and covenants of the County in effect at the time this contract is entered into; and this Contract.

It is expressly stipulated and agreed that the Contractor hereby covenants and agrees that the Contractor has full knowledge of the specifications and the experience to define quality services relative to the performance contemplated by this contract and made an essential part thereof, and that the affixing of signature hereto shall constitute complete acceptance of and compliance with aforesaid specifications, and conditions.

In consideration of the premises the County agrees to pay to the Contractor a certain sum of money, which shall be as set forth in said Contract hereto and made a part hereof. This aforesaid sum shall be understood to be NOT TO EXCEED:

TWENTY ONE THOUSAND SEVEN HUNDRED AND NO/100.....\$21,700.00

By entering into this agreement/contract I agree on behalf of the contracting or submitting business entity, its officers, employees, subcontractors, subgrantees, agents or assigns, to conduct this transaction by electronic means by agreeing that all documents requiring County signatures may be executed by electronic means, and that the electronic signatures affixed by the County to said documents shall have the same legal effect as if that signature was manually affixed to a paper version of the document. I also agree on behalf of the aforementioned entities and persons, to be bound by the provisions of Chapters 304 and 1306 of the Ohio Revised Code as they pertain to electronic transactions, and to comply with the electronic signature policy of Cuyahoga County.
