THIS Contract made and entered into this 5<sup>th</sup> day of March, 2012 by and between the County of Cuyahoga, Ohio (the "County"), and Western Farm Pet Crematory and Cemetery, Inc. (the "Contractor"), with principal offices located at 12521 Island Road, Grafton, Ohio 44044 on RQ23226.

WITNESSETH:

That for and in consideration of payments hereinafter mentioned, to be made by the County, the Contractor agrees to furnish all materials and labor, and perform all the work required for furnishing all materials and labor, and perform all the work required for Incinerator Services to the Department Public Works/County Kennel of Cuyahoga County, Ohio for the period May 16, 2012 through May 15, 2013 in accordance with the specifications and to the satisfaction and acceptance of the County.

The Contractor further covenants and agrees that the following documents shall be bound with or accompany and be an essential part of this contract: specifications predicated to this contract; the general clauses and covenants of the County in effect at the time this contract is entered into; and this Contract.

It is expressly stipulated and agreed that the Contractor hereby covenants and agrees that he/she has full knowledge of the site, plans, specifications, and conditions relative to the performance contemplated by this contract and made an essential part thereof, and that the affixing of this/her signature hereto shall constitute complete acceptance of and compliance with aforesaid specifications, and conditions.

In consideration of the premises the County agrees to pay to the Contractor a certain sum of money, which shall be as set forth in said Contract hereto and made a part hereof. Cremation Services per Pound = \$0.29 @ 52 Weeks per Year. This aforesaid sum shall be understood to be: **NOT TO EXCEED:**

SEVENTEEN THOUSAND FOUR HUNDRED AND NO/100.....\$17,400.00

By entering into this agreement/contract I agree on behalf of the contracting or submitting business entity, its officers, employees, subcontractors, subgrantees, agents or assigns, to conduct this transaction by electronic means by agreeing that all documents requiring County signatures may be executed by electronic means, and that the electronic signatures affixed by the County to said documents shall have the same legal effect as if that signature was manually affixed to a paper version of the document. I also agree on behalf of the aforementioned entities and persons, to be bound by the provisions of Chapters 304 and 1306 of the Ohio Revised Code as they pertain to electronic transactions, and to comply with the electronic signature policy of Cuyahoga County.
