



AMENDMENT TO CONTRACT

By and Between

CUYAHOGA COUNTY

and

C.B.Mullins Construction Company

This Amendatory Contract made and entered into on this 17th day of December, 2012 between the County of Cuyahoga, Ohio (hereinafter called "County") and C.B.Mullins Construction Company (hereinafter called "Contractor").

WITNESSETH:

WHEREAS, the County and the Contractor entered into Contract #CE1200579 dated September 17, 2012 (hereinafter called the "Contract") whereby the Contractor was awarded \$29,000.00 in funds for an activity entitled Lead Hazard Remediation for property located at 1570-72 Belmar Avenue, East Cleveland, Lakewood, in connection with the FY2010 Lead-Based Paint Hazard Control and Lead Hazard Reduction Demonstration Grant Program for the period 9/17/2012 - 11/16/2012 and

WHEREAS, the Contract expires on 11/16/2011 and

WHEREAS, the amount of the Contract reads \$29,000.00 and

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained, the County and the Contractor hereby agree as follows:

1. Except as herein specifically amended, all terms used herein shall have the same meanings as in the Contract.
2. The date of November 16, 2012 appearing in Contract Time of Performance of the Contract shall be and is hereby changed to May 31, 2013.
3. Attachment I – Not applicable. There is no change in the dollar amount of the contract.
4. Except as herein specifically amended, all of the terms and provisions contained in the Contract are hereby ratified and confirmed and said Contract is hereby incorporated to the same extent as if fully rewritten herein.

Electronic Signature Clause: By entering into this Amendment to Contract, I agree on behalf of the contracting or submitting business entity, its officers, employees, subcontractors, sub grantees, agents or assigns, to conduct this transaction by electronic means by agreeing that all documents requiring county signatures may be executed by electronic means, and that the electronic signatures affixed by the county to said documents shall have the same legal effect as if that signature was manually affixed to a paper version of the document. I also agree on behalf of the aforementioned entities and persons, to be bound by the provisions of chapters 304 and 1306 of the Ohio Revised Code as they pertain to electronic transactions, and to comply with the electronic signature policy of Cuyahoga County.
