

**AMENDMENT TO CONTRACT
CE-1000182**

by and between

CUYAHOGA COUNTY, OHIO

and

SERVICE EXPRESS, INC.

THIS AGREEMENT (the "Contract") is made and entered into this 11th day of JANUARY, 2013 by and between Cuyahoga County, Ohio ("the County"), on behalf of the Department of Information Technology and Service Express, Inc., ("Service Express"), a Michigan corporation with offices located at 3854 Broadmoor Ave. SE, Grand Rapids, MI 49512.

WHEREAS, The County and Service Express, Inc., entered into Contract No CE1000182, for maintenance services and system support of Hewlett Packard Servers; and

WHEREAS, The County, previously entered into an amendment to the original contract, CE1000182 adding maintenance for CRIS and CECOMS; and

WHEREAS, The County again entered into an amendment to, CE1000182, to update service, by removing and adding equipment coverage for countywide maintenance services and system support of Hewlett Packard Server Products; and

WHEREAS, The County now is in need to amend CE1000182, to extend the contract date by two months, to 2/28/13.

WHEREAS, this Amendment will cause an **increase** to the "not to exceed price" of the original Contract, as previously amended in the amount of Thirteen Thousand Two Hundred Ninety Six Dollars and Zero Cents, (\$13,296.00). The current "not to exceed price" shall then be Two Hundred Fifty Six Thousand Five Hundred Twenty Three Dollars and Thirty Three Cents, (\$256,523.33); and

NOW, THEREFORE, in consideration of mutual promises contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Service Express and the County agree as follows:

ARTICLE I – AGREEMENT AND TERM

- 1.1 Scope of Agreement. During the new term of this Contract, Service Express shall extend the contract for two months (1/1/10 – 2/28/13), to continue to provide the County with maintenance service and system support of Hewlett Packard Server Products Countywide, as listed on the attached quote dated 12/20/12, attached hereto as Schedule A, which will increase the

County's obligation under the current contract in the amount of Thirteen Thousand Two Hundred Ninety Six Dollars and Zero Cents, (\$13,296.00).

- 1.2 Term. This Contract Amendment shall be effective January 1, 2013; and, unless earlier terminated in accordance with the provisions of the Contract or subsequently amended, shall continue in effect for the new remaining period delineated in Contract CE-1000182 which is February 28, 2013.

ARTICLE II - ADDITIONAL MAINTENANCE SERVICE

- 2.1 At the request of the County and with the consent of Service Express may also provide technical, operational or other assistance on consulting to the County in excess of the scope of service included as Additional Maintenance Services would require an amendment to this contract.


