WHEREAS, the County has a present need for maintenance and support of its VMWare Software License; and

WHEREAS, OARnet offers to sell under government to government purchase maintenance and support services for VMWare Software License are available under ORC 307.86 (Competitive bidding required-exceptions.); and

WHEREAS, the County desires to avail itself of such services at the Cuyahoga County Department of Information Technology and OARnet/OSU is willing to provide such service to the County all upon the terms and conditions set forth herein, and

NOW, THEREFORE, in consideration of mutual promises contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, OARnet/OSU and the County agree as follows:

ARTICLE I - AGREEMENT AND TERM

- 1.1 Scope of Agreement. During the term of this Contract, OARnet shall provide to the County under this Maintenance and Support Agreement the coverage outlined in Quotes # 6246 & 6047 attached hereto and incorporated by reference herein as Schedule A insofar as the terms of Schedule A concur with this agreement. In the event that a discrepancy exists between the terms of Schedule A and this agreement, the terms of this agreement will be controlling and binding.
- 1.2 <u>Term.</u> The term of this Contract shall commence as of January 11, 2013; and, unless earlier terminated in accordance with the provisions of this Contract, shall continue in effect for one year from the date of commencement (1/11/13 1/10/14). This contract shall be in an amount not to exceed **Ten Thousand Eight Hundred Seventy-Six Dollars and Sixty Nine Cents (\$10,876.69).**

ARTICLE II - SCOPE OF WORK

2.1. Rendering of Services. OARnet hereby agrees to render the services outlined in Schedule A attached hereto and incorporated by reference herein at a total price which shall in no event exceed the amount of not to exceed Ten Thousand Eight Hundred Seventy-Six Dollars and Sixty Nine Cents (\$10,876.69).

ARTICLE III - PAYMENT AND INVOICING

- 3.1 <u>Payment.</u> During the term of this contract, the County shall pay the costs associated with the maintenance and support agreement yearly upon receipt of said invoice from OARnet and approval of the County Executive.
