

AGREEMENT

This agreement entered into this ____ day of March, 2013, between County of Cuyahoga, Ohio (hereinafter called the "COUNTY") and Playhouse Square Hotel Limited Partnership dba Wyndham Playhouse Square LLC (hereinafter referred to as Wyndham Cleveland at Playhouse Square) an Ohio corporation with offices located at 1260 Euclid Avenue, Cleveland, Ohio 44115 for the purpose of providing services for the 2013 Cuyahoga County Fatherhood Conference.

WHEREAS, the COUNTY desires to have the Wyndham Cleveland at Playhouse Square provide services that meet the community driven and designed objectives of the Cuyahoga County Fatherhood Initiative, which emphasizes services and programs for fathers and other male caretakers and to work with the Cuyahoga County Health and Human Services Department to build father friendly systems.

NOW, THEREFORE, in consideration of the mutual agreements contained herein, the COUNTY and the PROVIDER hereby agree as follows:

I. SCOPE OF SERVICES

The Wyndham Cleveland at Playhouse Square will provide meeting and banquet space for the Cuyahoga County Fatherhood Conference to be held on June 14th, 2013. The conference will include among other activities an opening Plenary Session, a Resource Fair, a Town Hall Meeting, a Fatherhood Awards Luncheon and Educational Workshops.

The Cuyahoga County Fatherhood Initiative shall:

Provide direction and oversight to the PROVIDER as may be reasonably expected or requested Based on Council direction.

Develop focus and tasks for the project including desired outcomes and indicators to be measured.

Regularly monitor development and provide assistance and direction as needed.

II. TERM

This contract will be effective from April 1, 2013 through August 1, 2013 inclusive, unless otherwise terminated or extended by formal amendment.

The total amount of the contract cannot exceed \$11,000.00 over the life of this contract.

III. CONTRACT TERMINATION

Either party may terminate the contract with a thirty (30) day written notice if applicable, and only those services actually provided through date of termination will be paid for.

IV. COMPENSATION/METHOD OF PAYMENT

The COUNTY agrees to reimburse the Wyndham Cleveland at Playhouse Square at the rate of \$11,000.00 based on completion of agreed upon activities verified by the Health and Human Services Department. The PROVIDER will submit, a detailed invoice specifying services to be provided. Once invoices are received and approved, payment will be made to the PROVIDER prior to the conference.

This contract shall not exceed \$11,000.00 based on agreed upon activities.

V. MODIFICATIONS

By the mutual written consent of the COUNTY and the PROVIDER, this Agreement may be modified whenever such modifications are deemed necessary. Any such modifications to this Agreement shall be reduced to writing and signed by both parties.

VI. ANTIDISCRIMINATION

The PROVIDER hereby agrees that in the performance of this Agreement, there shall be no discrimination against any person because of race, color, sex, religion, or national origin, as provided in the Title VII of the Civil Rights Act of 1964, and any such violation, thereof, shall be deemed a breach of said Agreement.

VIII. INSURANCE

The PROVIDER shall be insured or contract for such insurance as is responsibly necessary to adequately secure the persons against reasonable foreseeable torts, which would cause injury or death.

IX. INDEMNITY

The PROVIDER agrees to release, indemnify and to hold harmless the County and all its agents, representatives or employees from any and all responsibility or liability for the provider's failure to perform its duties and obligations under this contract.

X. ACCOUNTING AND REPORTING PROCEDURES

The COUNTY shall have access, for purposes of audit and examination, to any books, documents, papers and records of the provider that pertain to this contract with distribution determined by the hotel.

XI AMENDMENT

This Agreement constitutes the entire Agreement of the parties in the subject matter hereof and may not be changed, modified, discharged or extended except by written amendment duly executed by the parties. The PROVIDER agrees that no representation or warranties shall be binding upon the COUNTY unless expressed in writing herein or in a duly executed amendment hereof.
