## CUYAHOGA COUNTY COURT OF COMMON PLEAS, JUVENILE COURT DIVISION AMENDMENT TO THE CORNELL ABRAXAS GROUP, INC. CONTRACT FOR RESIDENTIAL TREATMENT SERVICES CE1300457

THIS AMENDMENT is entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2013 by and between the County of Cuyahoga, Ohio (hereinafter called the "COUNTY"), the Cuyahoga County Court of Common Pleas, Juvenile Court Division (hereinafter called the "COURT") and Cornell Abraxas Group, Inc., a corporation with principal offices located at 2840 Liberty Avenue, Suite 300, Pittsburgh, Pennsylvania 15222 (hereinafter called the "VENDOR").

## WITNESS THAT:

WHEREAS, the COURT desires to engage the VENDOR'S professional and technical services to conduct programming, treatment, case management, and care and custody services at the VENDOR's Intensive Drug and Alcohol Treatment Residential Facility located at 165 Abraxas Road, P.O. Box 59, Marienville, Pennsylvania.

NOW, THEREFORE, it is agreed that the CONTRACT by and between the COUNTY, the COURT and the VENDOR for services to be rendered from August 27, 2013 to December 31, 2013 is hereby amended to include the following revision to sections:

- To increase the funds in the amount of \$20,000.00. This changes the not-to-exceed value of the contract from \$25,000.00 to \$45,000.00.
- To extend the agreement for one (1) additional month, from December 31, 2013 to January 31, 2014.
- <u>ELECTRONIC SIGNATURES</u> By entering into this AGREEMENT, the VENDOR agrees on behalf of the contracting business entity, its officers, employees, subcontractors, subgrantees, agents or assigns, to conduct this transaction by electronic means by agreeing that all documents requiring county signatures may be executed by electronic means and that the electronic signatures affixed by the COUNTY to said documents shall have the same legal effect as if the signature was manually affixed to a paper version of the document. The VENDOR also agrees on behalf of the aforementioned entities and persons to be bound by the provisions of chapters 304 and 1306 of the Ohio Revised Code as they pertain to electronic transactions, and to comply with the electronic signature policy of Cuyahoga County.

All other sections of the original contract shall remain the same.

IN WITNESS WHEREOF, the COUNTY, the COURT and the VENDOR have executed this AMENDMENT to the CONTRACT.
