Personnel Review Commission

Background

Cuyahoga County Charter Article IX, Section 9.02 sets forth various responsibilities for the Personnel Review Commission (PRC), one of which is compliance with federal and state laws regarding personnel matters within the County Executive's organization and departments. This report has been prepared to assess compliance with the civil service laws of the County, the Ohio Revised Code, and the State of Ohio Constitution. A fundamental requirement of these laws is that appointments in the civil service of the County shall be made according to merit and fitness, to be ascertained as far as practicable by competitive examinations.

Objective and Methodology

This report is the annual summary of personnel actions for classified civil service positions within the County Executive's organization and departments and the assessment of the County's compliance with the various civil service laws that apply to the County. Throughout the year, the PRC establishes lists of eligible candidates deemed qualified for hire and provides those lists to the County's Appointing Authorities to make appointments. In turn, the County's Department of Human Resources, in conjunction with the appointing authority, periodically recommends hiring decisions from those lists. They create Personnel Agendas that include those recommendations and send them to the County Executive for final approval. This report is based on a comparison of the PRC eligibility lists and the Executive's personnel agendas. The report consists of the following information:

- Employee Name
- Type of Personnel Action
- Original Position (if any)
- New Position

- Bargaining vs. Non-Bargaining
- PRC Eligibility List Establishment Date
- Personnel Agenda Date
- Classified Status

The PRC worked collaboratively with the Department of Human Resources to address questions and concerns that arose during the preparation of this report, and several of the concerns identified initially by the PRC have been resolved. Specifically, the PRC acknowledges the assistance of Matthew Kelly, the County's Manager of Talent Acquisition and Employment, who was helpful in researching and resolving issues raised by the PRC staff. Those concerns which were not effectively resolved at the time of this report are described in the next section.

COMPLIANCE REPORT

This current report reflects a total of 744 personnel actions for permanent classified County positions in 2017. These include:

- 489 original appointments,
- 155 promotions within the same appointing authority,
- 16 promotions between appointing authorities,
- 54 reassignments,
- 1 reassignment and change of status,
- 6 lateral transfers,
- 1 transfer between agencies,
- 1 lateral classification change,
- 2 reinstatements, and
- 19 cancellations of appointments.

Temporary appointments and temporary work levels (TWLs) will be addressed in a separate PRC compliance report.

Currently, the PRC has confirmed that over 99% of the permanent classified personnel actions made by the County complied with civil service requirements (see Addendum A). Based on the information provided to the PRC at this time, the following personnel actions were not in compliance with the County's civil service requirements and the PRC's Administrative Rules.

Candidates not certified for appointment: These include original appointments to classified positions. The individuals appointed to these positions appeared on the pertinent eligibility lists, but the names were never certified to the appointing authority for appointment. In one instance, the request for certification occurred after the eligibility list expired, and no further names were certified for appointment. However, the appointment was still made in violation of civil service laws.

In the remaining cases, due to the number of vacancies in the classification of Administrative Assistant 1, the Department of Human Resources (HR) assumed they could appoint any name from the eligibility list without that name having been explicitly certified first. This was an incorrect assumption for the classification in question and violates the PRC's Administrative Rules regarding certification. This has been conveyed to HR, and the PRC has received assurances that this will not occur again.

This occurred for five (5) appointments, all of which are in Cuyahoga Job & Family Services.

Item #: 5, 297, 299, 301, 303

Reassignment and change of status: This personnel action involved changing an individual's status from unclassified to classified, and then the assignment of a classification to that individual without an open, competitive process for that position. Furthermore, there was an existing eligibility list for the classification in place at the time of the personnel action.

As described to the PRC by HR, the individual's position was originally deemed unclassified within the Department of Health & Human Services (HHS). However, the Ohio Revised Code limits the number of unclassified positions in a county's Department of HHS. The County decided to move this position back into the classified service so as not to exceed that limit, and it did so without a civil service process to fill the position. This action is in violation of the County's civil service laws.

This occurred within Cuyahoga Job & Family Services.
