

CORRECTED APPOINTMENTS REPORT 2020

Cuyahoga County
Personnel Review Commission

Background

Cuyahoga County Charter Article IX, Section 9.02 sets forth various responsibilities for the Personnel Review Commission (PRC), one of which is reviewing and auditing compliance with federal, state, and local laws regarding personnel matters within the County Executive's organization and departments. The PRC prepared the initial 2020 Appointments Report and thereafter learned that certain agenda items were inadvertently omitted from it and other items on it occurred in 2019. This is a corrected report that assesses compliance with the civil service laws of the County, the Ohio Revised Code, and the State of Ohio Constitution. A fundamental requirement of these laws is that appointments in the civil service of the County shall be made according to merit and fitness, to be ascertained as far as practicable by competitive examinations.

Objective and Methodology

This report summarizes the personnel actions for classified civil service positions within the County Executive's organization and departments during 2020 (including those agenda items inadvertently omitted from the original report), and the assessment of the County's compliance with the various civil service laws that apply to the County. The PRC establishes lists of eligible candidates deemed qualified for hire and provides those lists to the County's appointing authorities to make appointments. In turn, the County's Department of Human Resources (HR), in conjunction with the appointing authority, periodically recommends hiring decisions from those lists. HR creates personnel agendas that include those recommendations, as well as information concerning employee transfers and demotions, and sends them to the County Executive for final approval. This report is based on a comparison of the PRC eligibility lists and the Executive's personnel agendas, to verify that persons appointed to classified civil service positions were on an eligibility list established by the PRC and certified for appointment. The report consists of the following information:

- Employee Name
- Type of Personnel Action
- Original Position (if any)
- New Position

- Bargaining vs. Non-Bargaining
- PRC Eligibility List Establishment Date
- Personnel Agenda Date
- Classified Status

The PRC worked collaboratively with HR to address questions and concerns that arose during the preparation of this corrected report, and all the concerns the PRC identified have been resolved. The PRC acknowledges the assistance of Julie McNulty, the County's interim Talent Acquisition & Employment Manager, who was helpful in researching and resolving issues the PRC raised during its compliance audit.

COMPLIANCE REPORT

This corrected report reflects a total of 388 personnel actions for permanent classified County positions in 2020 and includes 48 personnel actions that were inadvertently omitted from the original report. In addition, 20 personnel actions that were included in the original report occurred in 2019 and have been removed from this corrected report. The corrected personnel actions reflected in this report include:

- 285 original appointments (21 in addition to the original report),
- 75 promotions within the same appointing authority (22 in addition to the original report),
- 17 rehires,
- 2 promotions between appointing authorities (1 in addition to the original report),
- 1 reassignment (the 3 reassignments on the original report occurred in 2019 and have been removed from this corrected report),
- 1 lateral transfer,
- 2 demotions (1 in addition to the original report),
- 3 voluntary demotions (2 in addition to the original report),
- 1 duplicate entry with an incorrect effective date (HR confirmed the correct effective date which is noted in the report), and
- 1 duplicate entry reflecting a pay adjustment (the first entry reflects the appointment date).

Temporary appointments and temporary work levels (TWLs) will be addressed in a separate PRC compliance report.

Currently, the PRC has confirmed that 100% of the permanent classified personnel actions made by the County complied with civil service requirements (see Addendum A).
