

# APPOINTMENTS REPORT 2021

Cuyahoga County
Personnel Review Commission

### Background

Cuyahoga County Charter Article IX, Section 9.02 sets forth various responsibilities for the Personnel Review Commission (PRC), one of which is reviewing and auditing compliance with federal, state, and local laws regarding personnel matters within the County Executive's organization and departments. The PRC prepared this report to assess compliance with the civil service laws of the County, the Ohio Revised Code, and the State of Ohio Constitution. A fundamental requirement of these laws is that appointments in the civil service of the County shall be made according to merit and fitness, to be ascertained as far as practicable by competitive examinations.

# **Objective and Methodology**

This report summarizes the personnel actions for classified civil service positions within the County Executive's organization and departments during 2021, and the assessment of the County's compliance with the various civil service laws that apply to the County. From its screening and civil service testing procedures, the PRC establishes lists of eligible candidates deemed qualified for hire and provides those lists to the County's appointing authorities to make appointments. In turn, the County's Department of Human Resources (HR), in conjunction with an appointing authority, periodically recommends hiring decisions from those lists. HR creates personnel agendas that include those recommendations and sends them to the County Executive for final approval.

This report documents the comparison of the PRC eligibility lists and the Executive's personnel agendas to verify that persons appointed to classified civil service positions were on an eligibility list established by the PRC and certified for appointment. This report consists of the following information:

- Employee Name
- Type of Personnel Action
- Original/"Current" Position (if any)
- New Position

- Bargaining vs. Non-Bargaining
- PRC Eligibility List Establishment Date
- Personnel Agenda Date
- Classified Status

The PRC worked collaboratively with HR to address questions and concerns that arose during the preparation of this report, and all the concerns the PRC initially identified have been resolved. The PRC acknowledges the assistance of Julie McNulty, the County's Talent Acquisition & Employment Manager, who was helpful in researching and resolving issues the PRC raised during its compliance audit.

# **COMPLIANCE REPORT**

This current report reflects a total of 683 personnel actions for permanent classified County positions in 2021. These include:

- 429 original appointments,
- 163 promotions within the same appointing authority,
- 23 promotions between appointing authorities,
- 34 rehires,
- 3 reassignments,
- 13 lateral transfers, and
- 18 demotions.

Temporary appointments and temporary work levels (TWLs) will be addressed in separate PRC compliance reports.

Currently, the PRC has confirmed that 99% of the permanent classified personnel actions made by the County complied with civil service requirements (see Addendum A). Based on the information provided to the PRC at this time, the following personnel actions were not in compliance with the Ohio Constitution, Article XV, Section 10, Ohio civil service laws, Cuyahoga County's civil service requirements, and the PRC's Administrative Rules.

### Candidates Not Certified for Original Appointment in Violation of Civil Service Laws

**Definition of an "Original Appointment":** Cuyahoga County Code (Code) Chapter 303 includes a description of the County's civil service plan. Sections 9.01 and 9.02 of the County Charter authorize the PRC to create rules and policies related to administering the County's civil service plan. The PRC Administrative Rules (Rules) set forth the policies and procedures governing classification plan administration.

Code section 303.05(a) generally defines an "Original Appointment" as the appointing authority's selection of a candidate from an eligibility list the PRC establishes to fill a vacancy in the classified service. PRC Administrative Rule 11.01 further defines an Original Appointment and requires the PRC to certify an eligibility list to an appointing authority. It is from a certified eligibility list that an appointing authority may select appointees. Thus, to comply with these civil service laws and rules, a person appointed to a classified position must have been selected from an eligibility list that the PRC certified to the appointing authority.

**Audit Findings:** This audit revealed that the Department of Health and Human Services made five appointments to candidates who were not certified for original appointments in violation of Code section 303.05(a) and Rules 11.01 and 10.01.

Three candidates were given conditional offers of employment after the eligibility list expired, and two candidates were selected from an eligibility list that was not certified. These appointments appear in Addendum A at Appts. Report Item ## (No.) 139, 257, 258, 647, and 655.

**PRC recommendation:** The Ohio Constitution, Article XV, section 10, requires appointments and promotions in the civil service of the County to be made according to merit and fitness, to be ascertained, as far as practicable, by competitive examinations. The County appointed these five individuals without the process they, and other candidates, were entitled to under the law. The PRC recommends that HR develop, implement, and utilize processes to ensure that all County appointments are made in accordance with the law. To be technically compliant with the relevant legal requirements, these appointments should be rescinded, and the County should follow established civil service regulations to make these appointments.

# **Insufficient Documentation of Conditional Job Offers**

There were four instances where the County did not produce sufficient documentation to establish compliance with civil service laws, demonstrating a lack of consistent procedure. In three of these cases the documentation did not establish that a conditional offer of employment was made before the certified eligibility list expired, and HR was unable to produce documentation to support their claims that these offers had been made before the eligibility list expired. In the other case, the offer letter did not include a date. These appointments appear in Addendum A at Nos. 209, 218, 259, and 504.

In one case, No. 209, HR was unable to produce a copy of a written conditional offer letter but produced an email chain showing that the applicant accepted a conditional offer before the eligibility list expired. In another case, No. 218, HR produced documents indicating that drug and alcohol screening occurred before the eligibility list expired, but no written conditional offer was provided, so this raises additional concerns.

**PRC Recommendation:** In all four cases, HR could not provide a properly dated written conditional job offer letter. These cases demonstrate a lack of compliance with best professional practices and potential violations of law. The PRC recommends that HR prepare and preserve written, dated, and consistently formatted conditional job offers for all appointments.

# **Errors in Data Entry on Personnel Agendas**

In conducting the audit, the PRC noted several instances where data entered into INFOR (the County's Human Resources Information System) was incorrect. In most of them, the incorrect appointing authority and/or job title was entered. These items appear at Nos. 77, 119, 137, 152, 153, 156, 266, 317, and 649. In other instances, incorrect duplicate entries were found. These items appear at Nos. 103, 320, 325, 540, and 641.


**PRC Recommendation:** Data integrity is key to having an efficient, effective HRIS system. To note, the PRC's classification and compensation system also occasionally notifies HR of errors identified in the County's employee records.

The PRC recommends that the County implement quality assurance procedures to ensure the accuracy of all data entered into the system that houses County employee data. Also, the PRC recommends that employees responsible for data entry in the system are trained sufficiently on issues such as classified status, appointing authority, and other items unique to public service, so they can develop an understanding of the importance of this data in the County's HR recordkeeping and operations.

## **Additional PRC Recommendations**

**Medical Examiner Office is an Appointing Authority:** In one entry on the attached report, No. 91, the Appointing Authority was listed as "Public Safety", however the PRC learned that the correct Appointing Authority was the Medical Examiner's Office (MEO). The MEO's office is an Appointing Authority separate and apart from Public Safety. (County Charter, section 5.03.) Accordingly, the MEO should be entered as the appointing authority in the County's recordkeeping system to accurately reflect the County Charter.

**Proper Action Type must be used:** In No. 143, the Action Type is shown as a reassignment, but it should have been noted, at least additionally, as a demotion, because the action resulted in a decrease in pay. PRC Administrative Rule 1.01(26) defines a reassignment as "[the] assignment of an employee to a different classification." Rule 1.01(13) defines demotion as: "The act of placing an individual in a position, at the request of an appointing authority or the employee, the classification for which carries a lower pay grade than that of the classification the employee currently holds." The PRC recommends that the County adhere to these definitions in its recordkeeping.
