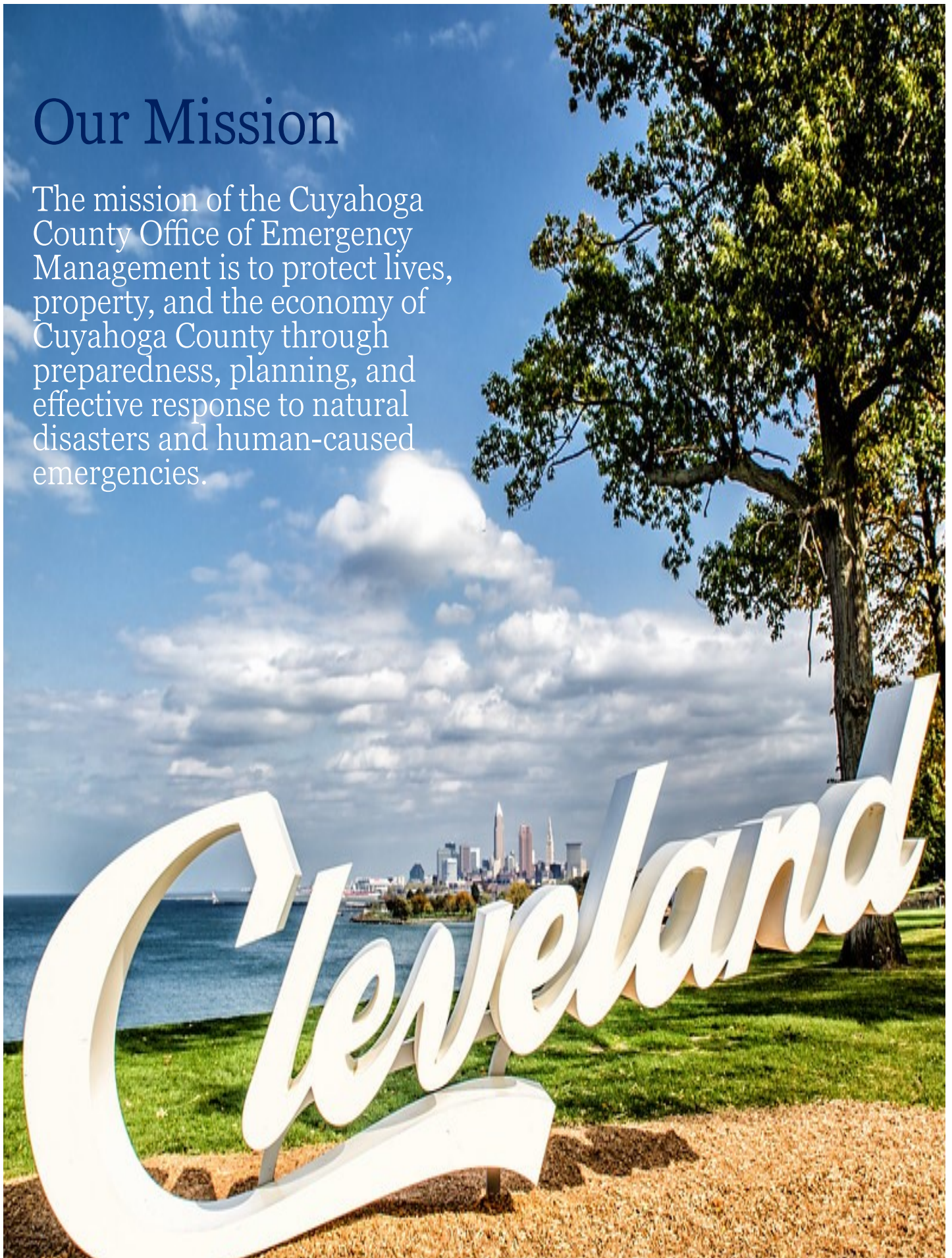

# Who We Are

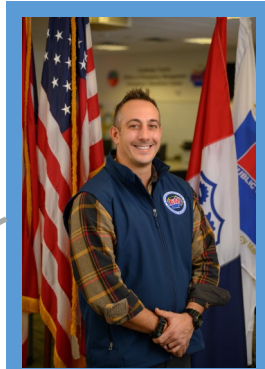

# Staffing Updates

The Cuyahoga County Office of Emergency Management (CCOEM) experienced several positive staffing changes in 2024, including the promotion of Sara Lippi to Sr. Emergency Management Specialist and welcoming a new staff member to the Operations Section, Omari Mays.

2025 is positioned to bring more staffing changes as CCOEM works to fill two vacancies: Emergency Management HAZMAT Analyst and Emergency Management Specialist.

## Sara Lippi, Sr. Emergency Management Specialist (Planning)



In July of 2024, Sara Lippi was promoted to Sr. Emergency Management Specialist. Previously, Sara had served the office for 5 years as an Emergency Management Specialist. Her new position moves her into the Planning Section of CCOEM. As such, Sara will take a lead role in many of the office's planning initiatives, including: continuity planning and maintaining all of the support annexes to the Cuyahoga County Emergency Operations Plan (EOP). Further, in addition to retaining her role administering the ReadyEx Tabletop Exercise Program, Sara will now oversee the office's ReadyCertify Program.

## Omari Mays, Emergency Management Specialist (OPS/LEPC)



Omari Mays was appointed to his position of Emergency Management Specialist in October of 2024. In that role, he is responsible for supporting the Local Emergency Planning Committee (LEPC) and performing other functions and activities within the Operations Section of CCOEM. Earning a Bachelor's degree in Criminal Justice from the University of Cincinnati, Omari is a native Clevelander with a passion for Public Safety. He also serves as a Military Police Officer in the Ohio Air National Guard.

## Emergency Management Accreditation Program (EMAP)

EMAP, an independent non-profit organization, fosters excellence and accountability in emergency management programs by establishing credible standards that are applied in a peer-reviewed accreditation process. Participation in the EMAP program is voluntary and demonstrates a commitment to continuous improvement.

In 2015, the Cuyahoga County Office of Emergency Management (CCOEM) became **the first locally-accredited agency in the State of Ohio.**

EMAP requires a five-year reaccreditation. As such, CCOEM achieved reaccreditation in 2021 and spent much of 2024 actively preparing for the 2025 reaccreditation process.

# Mass Notification

The Cuyahoga County Office of Emergency Management (CCOEM) maintains Cuyahoga County's mass notification system, ReadyNotify.

This system is used to send countywide emergency notifications and other messaging via phone calls, texts, and emails.

Additionally, CCOEM makes the system available for use by communities and other public safety partner agencies at no cost. Doing so enables a true countywide, mass notification system.

# ReadyCertify

The Cuyahoga County Office of Emergency Management (CCOEM ) maintains an emergency management certification program, ReadyCertify, intended to help Cuyahoga County communities and organizations increase their ability to plan for and respond to disasters or emergencies.

The core of the ReadyCertify program is a set of 24 emergency management performance standards carefully selected by CCOEM. They cover the full spectrum of emergency management activities including, but not limited to: Administration, Organization, Planning, Training, Response, and Recovery.

The ReadyCertify Program encourages the use of nationally recognized best-practices and increases the awareness, understanding, and appreciation of cooperation and interoperability among Cuyahoga County's communities and organizations.

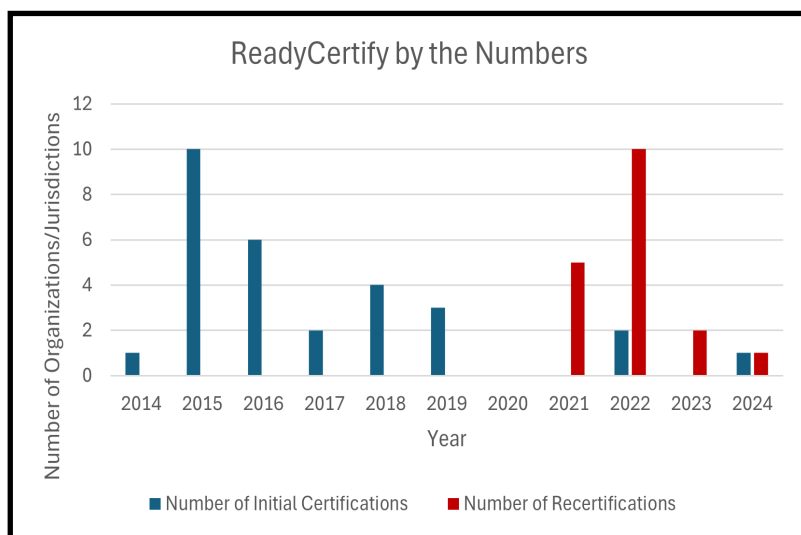
Recertification in the ReadyCertify Program occurs every 5 years.

In 2024, CCOEM proudly awarded the **Cuyahoga Community College** with their initial ReadyCertify certification and the city of **Middleburg Hts.** with their 5-year recertification.

Since 2014, **29** communities and organizations have completed the ReadyCertify Program.

# Planning

Emergency Management planning consists of writing, disseminating, and maintaining plans related to emergency preparedness, response, recovery, and mitigation.

At the County-level, the Cuyahoga County Office of Emergency Management (CCOEM) maintains the Cuyahoga County Emergency Operations Plan (EOP), incident-specific and functional annexes as well as the Emergency Support Function (ESF) annexes. Additionally, CCOEM also provides technical assistance to community and partner agency planning efforts. This year we updated our functional and incident-specific annexes. In 2025 we will be updating our 15 ESF annexes, and will engage 50+ agencies to provide their input.

## Cuyahoga County Long Term Recovery (LTR) Plan



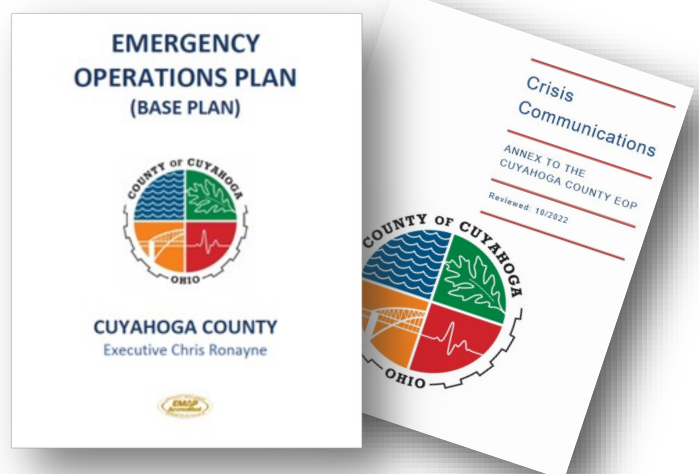
In 2024, CCOEM partnered with Ascentra Inc., to prepare a comprehensive Long Term Recovery (LTR) Plan for Cuyahoga County. The planning process solicited input from nearly **200 individuals** from a diverse range of agencies and organizations.

A final draft of the LTR Plan was completed at the close of 2024 and included separate annexes for access and functional needs populations, faith-based organization coordination, and recovery from incidents involving active aggressors.

# Continuity of Operations Planning (COOP)

The purpose of a Continuity of Operations Plan (COOP) is to ensure that organizations are prepared to continue essential services during and after an emergency event.

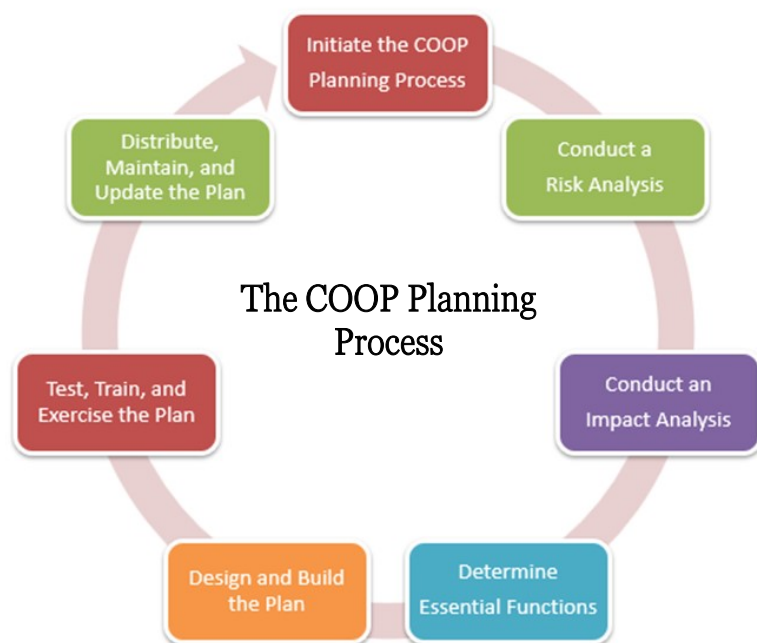
The Cuyahoga County Office of Emergency Management (CCOEM) maintains a COOP program for County departments and is available to assist municipalities and organizations in COOP planning efforts.

The CCOEM COOP Program consists of training, plan templates, exercise planning support, and supplemental resources. The program is designed to be applicable to government-agencies, private sector entities, and non-profit organizations.



In 2024 CCOEM worked with **16** County Departments and Divisions to draft or update existing COOP Plans.

# Operations

## EOC Activations & Operations Support in 2024

Emergency Management Operations include maintaining the County Emergency Operations Center (EOC) in a state of readiness, resource coordination, and providing in-field assistance during emergencies such as incident command assistance, Unmanned Aircraft Systems (UAS) support, and damage assessments.

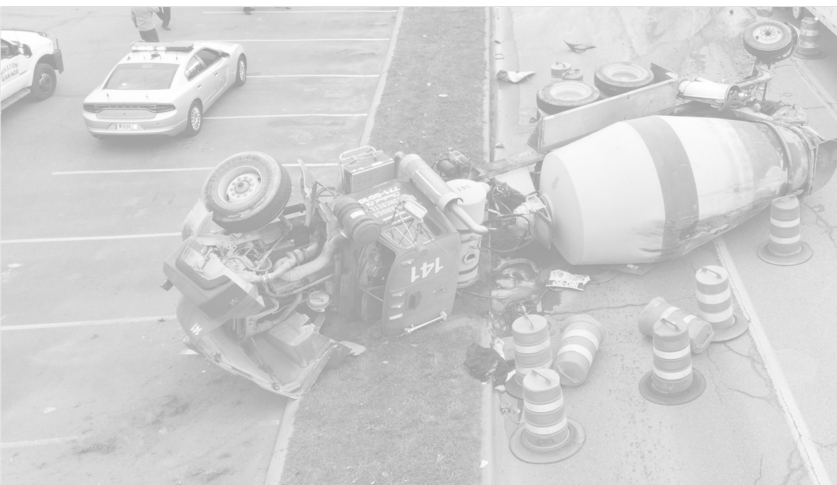
Although County-level assistance is not typically needed for routine incidents, if requested, Emergency Management staff is able to provide assistance to communities regardless of the size or scope of an event.

## Emergency Operations Center

The EOC is the central location from which all off-scene activities are coordinated. The key function of EOC personnel is to support the Incident Commander and ensure that those who are located at the scene have the resources they need for the response.



## Cuyahoga County UAS



CCOEM maintains a UAS team to serve as a resource for communities and partner agencies. Over the subsequent years the team has supported a variety of missions including search and rescue, fire operations, law enforcement activities, damage assessments, and large special events.

## Special Event Trailers



### **2024 Special Event Trailer Deployments**

**9 Deployments for 25 Days**

CCOEM maintains two Special Event Trailers that are available to communities, upon request.

The trailers are intended to be staged prior to community events (e.g. home days, festivals, etc.) and come equipped with supplies necessary to respond to medical emergencies and/or a mass casualty incident.

## Cuyahoga County Fire Chief's Association Rehab Vehicle

The Cuyahoga County Fire Chief's Association coordinated the purchase of a Mobile Command/Rehab Vehicle that is available upon request for emergencies and special events.

CCOEM stores the vehicle in the Emergency Management Warehouse in Newburgh Hts. and assists with its maintenance and deployments.





# Notable 2024 Operations

## Total Solar Eclipse

On April 8th, 2024, a total solar eclipse crossed North America. Portions of Ohio, including Cuyahoga County, were within the eclipse's path of totality, making the experience especially unique.

Due to the event's rarity, the eclipse was expected to draw big crowds and potentially create issues with traffic congestion, network disruptions, and cross-jurisdiction coordination.

Accordingly, CCOEM spent more than a year planning, hosting meetings, and sharing information with stakeholders. The Cuyahoga County EOC was fully activated the day of the event and fortunately, experienced no major issues.

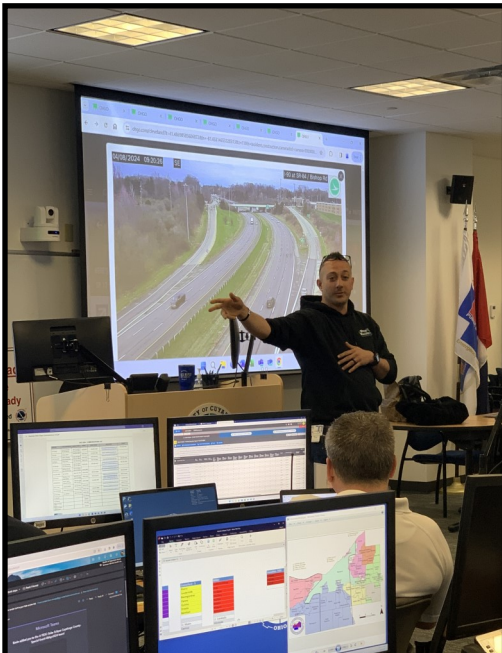

# Notable 2024 Operations

# August Tornadoes

On August 6<sup>th</sup>, 2024, 3 EF-1 tornadoes, a macroburst, and widespread straight-line winds impacted Cuyahoga County. The severe weather caused extensive damage to trees and homes, as well as prolonged disruptions to power and cellular communications throughout the County.

Ultimately, 13 communities experienced significant damage and storm-related issues. Consequently, Cuyahoga County qualified for State Disaster Relief Program (SDRP) funding, which enabled communities, and other eligible applicants, to access cost recovery opportunities.

## **Emergency Management Significant Actions**

- Performed Damage Assessment on 197 properties.
- Deployed a generator to a senior high rise apartment with critical power failure.
- Deployed and operated 2 oxygen trailers.
- Coordinated with ODOT to assist with debris/roadway clearing.
- Coordinated with Team Rubicon and the Southern Baptist volunteer chainsaw crews to assist residents with vegetative debris on their properties.
- Coordinated numerous briefings among response partners, elected officials, and the media.

# ReadyMaps

## ReadyMaps Resource Management System

The Cuyahoga County Office of Emergency Management (CCOEM) maintains a comprehensive resource database to expedite the request and deployment process of resources in the County.

The database was previously hosted within CCOEM's information-sharing system, *Knowledge Center*. In 2024 CCOEM began migrating to a new GIS-based platform, branded as *ReadyMaps*.

The resource database inventories approximately **2,300** resources from over **160** local agencies and organizations.

ReadyMaps enables CCOEM and response agencies to quickly identify and allocate resources during emergencies.

# LEPC

The Local Emergency Planning Committee (LEPC) is a planning group comprised of individuals who have a knowledge and awareness of hazardous materials incident planning and response. It is mandated by the Emergency Planning and Community Right-to-Know Act of 1986 as well as section 3750.03 of the Ohio Revised Code (ORC).

The Cuyahoga County LEPC is funded by the State of Ohio LEPC Grant Program and has 24 members that meet bi-monthly.

The LEPC's responsibilities include supporting first responders with hazardous materials information and training, overseeing annual chemical reporting for regulated facilities, and maintaining records for all spills and releases of hazardous chemicals in Cuyahoga County.

# Training & Exercise

## Training

The Cuyahoga County Office of Emergency Management (CCOEM) coordinates training opportunities throughout the year for local officials and public safety agencies. Course schedules are developed to support National Incident Management System (NIMS) training requirements as well as to address responder capability gaps. When appropriate, refresher courses are built into the schedule to allow for the maintenance of certifications and expertise.

# Integrated Response to Mass Casualty Incidents (IRMC) Training

Rescue Task Force (RTF) refers to a combination of law enforcement officers and medical personnel that can triage and treat victims in an unsecured working environment.

The concept is implemented for incidents involving active aggressors, in which immediate medical care is necessary to save lives.

The Cuyahoga County Office of Emergency Management (CCOEM) worked with the Cuyahoga County Fire and Police Chiefs' Associations to implement and sustain an RTF Training program to train personnel from local law enforcement and fire agencies.

Cuyahoga County's program is officially known as **Integrated Response to Mass Casualty Incidents (IRMC)** Training and ensures that a standardized and interoperable approach to the RTF concept is implemented across all law enforcement and fire departments in the County. The Cuyahoga County Department of Public Safety & Justice Services has allocated funding to support this program since 2022.

# ReadyEx Prep

Nearly four years ago the Cuyahoga County Office of Emergency Management (CCOEM) officially launched their tabletop exercise (TTX) program, *ReadyEx Prep*.

ReadyEx Prep is an expansion of the original ReadyEx TTX program that provides target audiences access to easy-to-use materials and guidance for conducting their own tabletop exercises.

ReadyEx Prep takes the original program a step further by providing in-person training on the process for designing and facilitating TTXs. Specifically, CCOEM staff host a half-day workshop where all essential exercise documentation is thoroughly reviewed and attendees are provided instruction on how to facilitate a TTX in the context of a plausible scenario.

In 2024, CCOEM hosted three more ReadyEx Prep sessions in Mayfield Hts, Fairview Park and Independence. The target audiences for each of these sessions were school and public safety personnel.


