The County disclaims all responsibilities or liabilities with respect to compliance with the SEC municipal advisor rule by any third party other than with respect to the information provided herein. The County intends that market participants may rely on the foregoing for the basis for any exemption under Section 15B (c)(1) of the Securities Exchange Act of 1934, as amended, with respect to the issuance of municipal securities or municipal financial products. Making any such determination is the responsibility of the party seeking such an exemption.
